Dear Mr. Lindback:

Per our conversation with the Elections Division, I am submitting this notarized letter from the Oregon Medical PAC (000171) concerning the Notice of Proposed Civil Penalty referencing case number L9067. The reason for the notice was a failure to report an expenditure of \$650.00 to the American Medical Political Action Committee on May 8, 2006.

The Oregon Medical PAC maintains two separate, segregated bank accounts for contributions from our members.

1. Oregon Medical PAC US Bank (xxx-1877) is for checks received from the personal accounts of our contributing members;
2. Oregon Medical PAC US Bank (xxx-1893) is for checks received from the corporate (office) accounts of our contributing members.

I reported an expenditure of \$1150 made on May 8, 2006 from our US Bank account (xxx-1877) because the amount met the criteria for the 2nd Supplement to the Second

Pre-Election report. I did not report the \$650 expenditure made on the same day from the US Bank account (xxx-1893) because it did not meet the criteria for the report. I have now amended this report (copy attached) to reflect the difference between the two different bank accounts.
